People want to know what we've done and what we are capable of doing. After reading the following list (which I'm sad to say doesn't include everything - there just isn't room!), I hope everyone has a better idea of how JCTA can and does work for them:

- •JCTA has processed and resolved grievances for teachers in all areas of the contract including discipline, evaluation, assignment, etc.
- •JCTA enlisted the help of members to produce commercials promoting teachers
- •JCTA is working with members who are concerned about student discipline problems in their school
- •JCTA negotiated and has implemented new procedures for teachers facing the non-renewal of their contract
- •JCTA helped elect pro-public education candidates during the November elections and tackled tough issues within the legislature during this year's legislative session
- •JCTA has already begun working with KEA on initiatives for the 2010 legislative session to ensure your benefits and to increase your salary
- •JCTA staff continue to participate in trainings at the state and national level in a process of ongoing learning that helps them to help you!
- •JCTA provided trainings for new Professional Representatives, SBDM Council members and new teachers
- •JCTA is planning trainings for the coming school year on an advanced level for Professional Representatives
- •JCTA has helped teachers with the NEA attorney referral program and in obtaining legal assistance from KEA for arbitrations, mediations, EPSB issues, etc.
- •JCTA is assisting teachers in signing up for the JCTA Sick Leave Bank and in obtaining days from the Bank
- •JCTA continues to provide members with representation during due process meetings
- •JCTA is working to revise the JCTA website and added a Facebook page
- JCTA has assisted members with assault/injury situations
- •JCTA has assisted members in obtaining proper District assistance when filing charges against students
- •JCTA has represented members during District and CPS investigations
- •JCTA hired more staff to provide even more assistance
- •JCTA held a fall luncheon for retired members and are preparing for the retirement dinner.
- •JCTA is assisting up and coming teachers through the NEA Student Program
- •JCTA has counseled and assisted members in utilizing appropriate leave time
- •JCTA has helped teachers with and through the arbitration process
- •JCTA was successful in many arbitrations this year including two that put teachers back to work who were wrongfully discharged

### **Important Information for 2009 Retirees**

If you are planning on retiring this year, you should first request a KTRS Form 23: Application for Service Retirement packet from the KTRS office at least 60 days before your prospective date of retirement. JCPS will be required to fill out a part of the retirement application (Sections VII and VIII) so be sure to allow sufficient time for this process as well. The deadline to file for a July 1st retirement date is June 1, 2009. Keep in mind that all retirement applications must be submitted by the FIRST of the month PRIOR to the month of retirement. July 1st retirees will receive their first annuity payment by direct deposit on July 29th. For more information, please contact the Kentucky Teachers Retirement System at 502-848-8500.

## Teaching Contracts

If you have signed a teaching contract for the 2009/10 school year, be advised that if you must break that contract **FOR ANY REASON**, you must do so at least fifteen (15) days prior to the start of the 2009/10 school year. If you do not, you can be found in breach of contract.

### **Call First**

Spring is a very busy time around the JCTA office. If you need to meet with your UniServ Director, please be sure to call the office to schedule an appointment or to make sure that your UniServ Director will be available if you plan to drop by. Call 454-3400.

### **Itinerants**

For purposes of planning, inventory, and storage of equipment/supplies, itinerant teachers NOT returning to a school should not be schedule for classes the last instructional day at that school. Itinerants who will be returning to their school for the 2009/10 school year should be free of classes at least half of the last instructional day at that school. This obviously can affect teachers' planning time, so now is the time to prepare! If you have questions, please contact JCTA.

## **Personal Days**

As we head into the final days of the school year, please remember that the contract DOES NOT allow for personal days to be used during the last five (5) days of the school term. JCTA interprets that to mean the last five (5) student days. Be advised that of the two (2) remaining work days for teachers that go beyond the school term, one (1) of those days is a professional development day (Gold Day).

# Purchasing 2008/09 Service Credit

Teachers who had unpaid contract days in the 2008/09 fiscal year (July 1 – June 30) should contact the Kentucky Teachers Retirement System (KTRS) at 502-848-8500. The deadline for purchasing this type of credit is December 31, 2009. If you were granted an unpaid leave of absence during the 2008/09 fiscal year, the deadline for purchasing these days is June 30, 2010. Mark your calendars and act accordingly because the longer you wait to purchase the service credit (after the deadlines have passed) the more expensive the cost.

## Planning Time – Business as usual

Teachers, the end of the school year is fast approaching, but as far as your rights under the contract are concerned, everything should remain BUSINESS **AS USUAL!** We are getting calls from teachers about their planning time being reduced or completely cut during testing, for field days, for assemblies, etc. - this is not acceptable! Teachers at the middle and high school levels are entitled to 50 minutes of planning per day. Elementary teachers are entitled to 200 minutes of planning per week. There are no exceptions. If your planning time is being affected, contact your UniServ Director to discuss your options.
